



# MEMBER USE AGREEMENT

## TERMS AND CONDITIONS

**Members may have non-exclusive use of the Sarasota Outboard Club clubhouse upon the following terms and conditions:**

1. The member must be in good standing.
2. The member **must be present** when the clubhouse is in use whether a member or guest event.
3. The member shall not use the clubhouse for commercial or profit-making purposes.
4. A \$150.00 plus \$10.50 use tax (\$160.50) donation must accompany this application for use by a member. (Member/Personal)
5. A \$150.00 plus \$10.50 use tax (\$160.50) donation must accompany this application for use by a guest of a member. (Member/Affiliated)
6. I agree to pay \$2.00 per bag of ice used for the function/event.
7. A Clean-up/property damage deposit in the sum of \$250.00 must accompany this application. This deposit will be refundable upon satisfactory inspection.

Application for reservations shall be made in duplicate and be presented to a Board Member prior to a monthly board meeting, and the Board shall make the final determination of approval. Application should be made in as far in advance as possible so that the Board may do its best to accommodate the member.

## CLEAN UP OF THE HALL AND/OR KITCHEN, COOK SHACK AND GROUNDS

The member shall be responsible for any and all damage to the structure and/or furniture and for the clean-up of the hall, kitchen, grounds and cook shack, if used. Clean-up shall be prior to leaving or in no event later than the day following the event. Clean-up shall include all facilities used, including decorations, mopping the floor, cleaning the refrigerator, emptying all garbage cans, cleaning of the restrooms, and restoring tables and chairs to their original locations. All lights are to be turned off, except for the security light in the west area of the hall. The gas stove and water must be turned off before leaving the premises. The air conditioning must be turned off. Failure to abide by this agreement as determined herein shall cause forfeiture of all or a portion of the security deposit. Damages not covered by the security deposit shall be paid by the member.

Execution of the application shall be deemed acceptance of the terms and conditions set forth herein.
